10. Any Other Business

1. Completion of Audit 2023-24

Documentation received after Agenda sent out. The audit is now complete, and the notice of completion was placed upon the notice board (photo taken) and will be placed on the website. Clerk advised Councillors that the audit was Qualified and what this meant and detailed the recommendations.

- 2. ROSPA report 2025 had been received after the Agenda had been sent out and a copy has been sent out to everyone. This is to be placed on next month's agenda for when everyone has had an opportunity to read it. In the meantime, all agreed that the invoice for the report should be approved for payment.
- 3. HD raised the issue of the condition of the unclassified road between Parthygwyddwch and Tydfarch, which forms part of one of the villages circular walks and is also part of the coastal path. The path is used by both walkers and off roaders and the condition had deteriorated badly. Clerk asked to write to GCC Highways and to Coastal Paths (Rhys Gwyn Roberts) regarding the condition.
- 4. GE raised the issue of the new benches and suggested these are secured in place following the theft of the concrete ends of the broken bench by Quakers. All agreed the benches should be secured.
- 5. GE raised the issue of Christmas trees and whilst Llwyngwril is sorted, raised the question about what was intended for Rhoslefain. Suggested by HD that we wait a while to see how the frame is he constructing turns out before deciding.
