- 2. Chairperson's Welcome: A warm welcome was extended to all to the meeting.
- 2.1 Registration of Interest: None.

# 3. Approval of previous minutes - 11/12/24:

9. County Councillors Report: None

#### 10. Any Other Business:

- a. MG advised of a problem with raw sewage on the plot of land belonging to M Black on Station Road. Numerous complaints had been made to Welsh Water, and they had attended and fixed the issue. However, it appears to be leaking again from a different spot and this time is closer to the river. This time the problem remains despite numerous complaints. Clerk asked to send a letter immediately to the Sewerage Department and that C. Cllr L. Hughes to be copied in.
- b. KC confirmed that he had now changed the broken timbers on the Rhoslefain bench and had repainted both benches.
- c. GE advised that the downstream wall of the red bridge is leaning with the potential to fall into the road. All agreed that a letter should be sent to Adrian Williams, GCC.
- d. GE raised the subject of bench maintenance and said that every bench (except for the blue bench in the playpark as that does not belong to the Council) requires cleaning, sanding down and staining. Clerk was asked to establish whether there were any local contractors who may be willing to undertake the work.
- e. GE mentioned that there were moles in the playpark again. GM will speak to Grace and see if she is able to assist but it is unlikely to be until after half term.
- f. JL brought in the two defibrillators that had been donated by the First Responders. Discussions took place regarding purchase of boxe(s) and having them installed on poles. DG and JW are taking responsibility for the defibs and will start things moving now we have them. JL stated that Chris Lawrence had checked the defibs recently and the battery was low in the defib at Y Ganolfan. For now, it was suggested using one of the donated batteries which had another two

years lifespan on it and to purchase a further battery when we were ready to install the donated defibs. It was agreed that the defibs should be placed at Gwastadgoed and The Green, Godre Gaer. Clerk advised the Cllrs. that a donation of £250 had been received from the First Responders towards our defib fund and a letter of thanks would be sent. KC proposed that as there were surplus funds in the bank account any shortfall for purchasing the second box should be made up from those funds, and that the Council should look at purchasing a new bench for the village from the funds also. There were no objections.

g. HD mentioned that he was continuing to look into making an Aluminium framed Xmas tree and asked for permission to purchase some aluminium scaffolding poles for the sum of £88. This was approved, and the invoice will be provided to the Council for reimbursement and reclaim of any VAT.
